### Lima Presbyterian Church fire investigated as an arson

When the church organist arrived at Lima Presbyterian Church this past Sunday (August 23) at 9 a.m., he discovered something that no one wants to discover.

The organist, Peter Geise, found the building, located at 7295 West Main Street in the village, full of smoke. He immediately called 911. Lima Fire Department, Honeoye Falls Fire Department and East Avon Fire Department responded, along with Lima Volunteer Ambulance and the Livingston County Sheriff's Department. It was discovered that someone had broken in, removed the pulpit Bible, put it on the floor by the front pew and set it on fire. The fire had apparently smoldered for some time, burning the Bible, the pew cushion, the front pew and the floor in front of the pew.

The firefighters put out the fire and then went to work using fans to help ventilate the historic building, which is at the four corners of the village (the intersections of Routes 5 & 20 and Route 15A). The church, built in 1873, did not have much fire damage, but there was a lot of smoke damage. Church officials do not know if the smoke damaged the church's pipe organ. The organ was dedicated following a restoration project in November 2018.

Pastor David Kilgore was on vacation so Rev. Bruce Boak, the substitute pastor for the Sunday worship service, gathered worshippers together (the church began limited inperson worship on July 5) and held a brief service on the church's front lawn


CALL THE UNDERTAKER -

Okay, we have one final brush with death at the American Hotel to share with you and after that we promise to bring you back to life and then warm you up with a bowl of hot American Hotel soup. The star of this last story is one Mark Kling who lived on York Street until his later years when he moved into the American Hotel during the era that long-term occupancy was still an option in the

At that point in time a new family tradition was established whereby every Sunday they would drive over, pick Mark up, and bring him back to York Street for a homecooked meal. The ritual became that Mark's grandson, also named Mark, would come into the hotel to get him while the rest of the family waited in the lobby visiting with the Reynolds.

On one particular day, grandson Mark came downstairs tearfully emotional. He said, "Grandpa is dead. I couldn't wake him up; I touched him and he was cold." A call went into Jimmy O'Conner, Lima's undertaker, who promptly responded. Upon entering the room Jimmy approached the bed to begin his preparations. Imagine his surprise when Mark rolled over, sat up, and said, "Who the hell are you?"

As we prefaced this component on deaths that have occurred at the American Hotel, we told you to keep in the back of your mind that notion that sometimes people are not as dead as they seem to be. So as opposed to our previous tale, this one provides its own happy ending. And on the subject of happy endings we are about to wrap our rendition of Reynolds reminiscences. We will continue



to keep you updated on the 100th anniversary year of the family owning, operating, and living in the big yellow building which looms large over Lima.

**FULL CIRCLE** - As we've described, the Reynolds family has lived on the third floor of the American Hotel building for 100 years now. They rent out seven rooms on the second floor. The cost of the rooms are \$80 or \$90 a night with the more expensive rooms boasting private bathrooms. Some rooms can be connected to create a suite and every one of the rooms can be seen on the hotel's website.

In the present day most of the actual dining takes place in the tap room. The original dining room is still available for special functions. We encourage our readers to keep this in mind. If you're looking to schedule an event for 40 people or less, you absolutely could not find a more historic setting in our community than the American Hotel.

If you're looking at booking any special event such as a birthday party, family reunion, wedding/baby shower, or any other group function, you may want to consider the American Hotel. Just remember, don't try to steal the art on the wall.

SOUP TO NUTS - The American Hotel is most famous for their homemade soups. Rose Reynolds is the soupmeister, and she has over 400 different soup options at her disposal. These include tantalizing Thai peanut, cauliflower cheddar, and two New England clam chowders. She says the most popular are split pea, cheeseburger chowder and crab broccoli bisque. She makes 3-4 soup varieties daily and they are always served with a complimentary homemade cookie.

Rose has written three cookbooks, Never Enough Thyme, Hold the Chicken and Make it Pea and You and the Horse You Rode in On. You can call the hotel to order your cookbook, they are available online, or better yet you can swing by the American Hotel in person, enjoy a bowl of soup and a cookie, and walk out with your personalized autographed Rose Reynolds cookbook.



#### **WOOIN' WHEATLAND ~ HOME OF** THE ORIGINAL MARLBORO MAN

For the past three weeks we have been sharing the story of Scottsville's most famous family, namely the Clunes. Henry Clune was a writer who authored 14 books and for decades his "Seen and Heard" column was a mainstay of the Rochester Democrat and Chronicle. Soon after Henry began his writing career he met and married Charlotte Boyle Clune who was a world class swimmer and member of the 1920 U.S. Olympic Swim Team.

**LEGACY LIVES ON** ~ If you thought the Clune family fame only lasted through this one generation, you'd be sadly mistaken. The Clunes had four sons, one of whom, Bill Clune, went on to achieve national success in the combined fields of modeling and advertizing. Turns out Bill Clune was the original Marlboro Man.

For the majority of our readers the Marlboro Man might be a mystery. The reason for this is that on October 20, 1971 it became illegal to advertize cigarettes on TV or radio. We bet most of you do recognize Marlboro as a cigarette brand and the Marlboro Man advertizing campaign was arguably the most successful in the history of

Okay now please allow us to connect the dots on this one. Henry and Charlotte Clune's son Bill grew up in Scottsville and his first job was working on a farm for \$35 a week. But Bill had aspirations for something more high profile and he managed to land a job as an announcer for radio station WBBF in Rochester in the early 1950s, his weekly soaring to \$55. Unfortunately that gig ended prematurely when Clune allowed some on-air profanity to slip out one Sunday.

SCOTTSVILLE TO NEW YORK CITY ~ From farming to radio, getting fired gave him the push to head to New York City with only \$100 in his pocket. His goal was to

get into modeling and he managed to carve out a rather unique niche in the field which, for a period of time, secured him a position as one the most highly paid male models in the field.

In a few ways, the stars aligned for Clune who more than readily admitted he did not have "pretty boy" looks working in his favor. But at that point in time, Marlboro happened to be looking for rugged, rather than pretty, and Clune filled the bill.

The Marlboro brand had originally been pitched toward women as "Mild as May." By the early 1950s the tobacco company was looking to change that image and looked to link the brand with one of America's most masculine icons - the cowboy. Marlboro thought that Bill Clune had just the right look to represent the rugged image they were seeking.

MAKING IT BIG - For the next two decades in the 1950s and 1960s, Clune became one of the most photographed men in America. His unconventional tough guy look attracted Madison Avenue ad executives who sought that outdoorsy look. Following the Marlboro Man, Clune appeared in other cigarette advertisements for Kool and Winston

He also appeared in ads for other products, Remington shavers being one of these. The pitch line for that product had Remington declaring it as "Remington Tough." At the rate of \$60 an hour, Clune was one of the highest paid models of the era. Not bad for a kid from Scottsville who was fired from his \$55-a-week radio job at WBBF for swearing on the air.

Ironically the Marlboro Man never smoked, a factor in which may have contributed to his longevity. At this point, now in his 80s, Clune has retired back to Scottsville to live out his Golden Years.

In the opening scene of Citizen Kane, the titular protagonist breathes his last breath. "Rosebud," he whispers as he releases his last grasp of a snow globe that falls to the floor and shatters.

We then spend the next two hours reliving the life of Charles Foster Kane as reporters vainly search for the meaning of his last word. Why would the world's richest man, a collector of antiquities galore, a prominent citizen, say "Rosebud"?

What did "Rosebud" mean to Charles Foster Kane?

More importantly, what does 'Rosebud" mean to us?

In the interest of avoiding revealing a movie's ending, I won't tell you what "Rosebud" represents in Citizen Kane. If you're one of the rare people who have not seen what many call the greatest movie of all time, well, I'd feel bad if I spoiled

Less important than the physical nature of "Rosebud" is the metaphysical nature experienced in the search for "Rosebud." If the movie told you what "Rosebud" was at the very beginning, it's poignant significance would be lost. So, you must suffer through Charles Foster Kane's entire life before you can appreciate "Rosebud." OK, OK, I know. I probably

scared you by using the word "metaphysical." You might "metaphysical." You might not be comfortable with such philosophical meanderings, but you know what it means.

The physical world is rigid. You can grab it, like Kane grabbed his snow globe. More so, you can feel it with your fingertips.

### When Did You Start Your Rosebud Quest?

The metaphysical world is abstract. You can't grab it, like Kane can't grab his memory of "Rosebud." You can only feel the abstract in your

that's where your Rosebud resides.

of your life than it is to uncover the Rosebud deep within

your heart. Think of Rosebud as the reason for the meaning of your life.

Allow me to explain this in mathematical terms. You might remember taking geometry in high school. You would be asked to put together a series of logical mathematical statements to create a "proof." This proof represents a practical reality. It's rigid. In the sense that a proof leads directly to engineering, you can feel it with your

But what came before the proof? What were the initial building blocks, the foundation from which you built your proof? Those were (and continue to be) called "axioms." Axioms represent truths so fundamental that everyone accepts them without question. An axiom is abstract. You can't prove it. You can only believe it in your heart.

As you progress in life, you move from the axioms your parents, teachers, and pastors impressed upon you in your youth, to the personal proofs you constructed for use in your adult life. Why do proofs become more important? Because you live in a world of proofs. Axioms have very little practical

Except, without axioms, you would have no proofs, and without Let's focus on "memory," for proofs, you would have no world,

It's a lot easier to discover the meaning of your life than it discover the meaning of your life. Think of Rosebud as the reason for this realization, that's the meaning of your life."

See how this is beginning to get

Charles Foster Kane had a very evident proof: he instinctively sought to - and often succeeded in - doing the very thing everyone told him he couldn't (or shouldn't) do. This simple rule dominated his life. It brought him to soaring heights. It led him to his lowest lows.

It defined the meaning of his life, but it failed to explain the reason for that meaning. That would be Kane's axiom. That axiom would be, for him, Rosebud.

When you reach a certain age, you throw away the axioms because the proofs provide all the direction you need. Axioms are nothing more than childhood trinkets. You want to keep them for nostalgic purposes, but you end up throwing them away when your basement gets too

As you get older, something different happens. You've lived a life that honors your proofs. Because your proofs are based on axioms,

your life also honors the fundamental axioms upon which your proofs have been built.

But, at some point, you get curious. As confident as you are in those proofs, you can't rebuild them if called to do so. That's

because you long ago threw out the axioms you needed to build

when you start your Rosebud Quest.

Everyone begins their Rosebud Quest eventually. Charles Foster Kane didn't begin his until his last dying breath. (Or was his entire life a search? The movie doesn't provide a definitive answer.)

If you've read this far, it means you're curious. It also means you've either already started your Rosebud Quest or are about to undertake it.

As someone far into this journey, I can be your Sherpa, at least until you reach base camp.

Before you take your first step,

try to remember when you tossed aside your axioms. I can remember exactly when I did it. I was a young teenager in the early years of high

I was very practical back then. It was the result of one of many proofs I carried within my brain. I correctly assumed my axioms were just collecting abstract dust. I mistakénly assumed my brain was reaching capacity and I needed to make room.

I incorrectly assumed these axioms were so universal they could never be forgotten. I figured, because they were universal, they'd be readily accessible in some handy reference work.

I was wrong.

And so I forgot my axioms. To this day, I don't know what

Ironically, it was in college when I began my Rosebud Quest. So certain was I of their validity, that I wanted to share them with my friends who had not had the advantage of understanding them.

You may have had a similar experience. Or you may have discovered your need to recapture your axioms when you had kids. I know, for me, having kids elevated the need to find those axioms.

Unfortunately, once Rosebud is lost, it's hard to find.

Actually, it's not that hard. All you need is a time machine.

OK, there's no such thing as a time machine, so it really is hard.

The closest thing we have to a time machine is a journal, a diary, or a newspaper. Other than that, we have people's memories.

And memories can be tricky things. You can't rely on only one set of memories. You need to triangulate. Get as many memories as possible and find the midpoint. Start with your own, expand to your family, then tap into your friends.

Have an open discussion. Any little piece of data can trigger a flood of memories.

Be warned though, the further back in time you go, the fewer data points you have to triangulate.

You will reach a point where you will need a leap of faith to find your Rosebud.

And, more than anything else, that requires your heart.

#### **Counties Recognize Actions of New** York Farmers to **Maintain Food Security During Pandemic**

Call for Preservation of Funding for Critical Agriculture Programs

The New York State Association of Counties announced today its Agriculture and Rural Affairs Standing Committee moved a resolution acknowledging the work of New York's farmers during the COVID-19 pandemic to provide nourishment and food security to all New Yorkers despite facing tremendous economic challenges.

"As many other businesses were forced to stand down, New York's farmers stepped up, donating thousands of pounds of fresh products to food banks across the state to help feed those in need during this crisis," said NYSAC President John F. Marren. "New York farmers are 'New York Tough,' but in this challenging economic climate, it's more important than ever for the State to maintain funding for programs that will help the agriculture community recover from this crisis."

The resolution moved by the Committee urges the State to protect critical programs that enable farms to continue farming and notes that these programs are needed to promote New York State products, provide critical applied research, ensure access to markets, and educate the public, and connect them to their food.

While counties appreciate the funding that Governor Cuomo and the State Legislature have provided for agriculture programs in the FY 2020-



#### **Revisiting HF Cemetery – Part II Summer 2020**

News & Notes from Honeoye Falls (Community) Cemetery

Honeoye Falls Fire Department

(May 4th, 2006)

It took a powerful stream of water, propelled high over the Methodist Church steeple, to prove to residents that Honeoye Falls was entering a new era.

No more would the bucket brigade and hearts steeled in courage be the only defense against conflagration... the newfangled Silsby Steamer had shown its mettle! "Now," they said, "let's quit dreaming and organize a fire department!"

And it was done.

Six score and one year ago, 1885, the Honeoye Falls Volunteer Fire Department organized nearly 150 men into four companies - the Wilcox Steamer Company, hauling around the Silsby behind rugged fire horses; the Downey Hook & Ladder Company; and two hose companies. The prominent sponsors of the first two outfits - Sylvester Wilcox and William Downey - have impressive cemetery monuments to match their legendary status in village annals.

The coming of *HFVFD* was just in time, too, since the great fire of May 1885 leveled the Village Hall and most of the block around it. But it didn't level the town, for the stout new fire companies turned out en masse to keep the flames

Since that compelling time in our history, fires that could have been 'devastating' have been relegated to 'aggravating.' Many have been major, multiple-alarm, expensive affairs, but none have taken out entire business blocks, like so many other communities. Every day, we should remember whom to thank.

This month of May, HF Cemetery will commemorate the formation of HFVFD by marking the graves of the exempt fire fighters - those who were not obligated to military service, jury duty, etc., in trade for their fire protection service.

Look for their special flags and recall a date when fire intruded on your life - then find a firefighter to hug.



As of 2020, the heritage of the Honeoye Falls Volunteer Fire Department extends back 135 years.





because the church was now a crime scene. They gave thanks to God for the minimal damage to the building, for the first responders and also prayed for the person(s) who set the fire.

'My wife and I pulled in about 9:10 a.m. and Peter said that he had called 911 because of smoke in the church," said Boak by phone on Monday night. "The fire departments got there right after we did."

For Rev. Boak, in a way this was deja vu all over again as Yogi Berra used to say. Boak was pastor of the First Presbyterian Church of Pittsford when it was struck by lightning on May 20, 2004. The lightning strike caused a fire that heavily damaged that church, causing its roof to collapse into the

"Obviously, this is much worse because this was a deliberate act as opposed to a lightning strike, which is an act of Mother Nature," Boak said. "At the brief worship service outside on the lawn, we had some Scripture readings and prayers; prayers of thanksgiving that the church had minimal damage, prayers for the first responders and prayers for the person or persons who did this. We also prayed for all victims of fires, such as the people enduring the wildfires in California."

Kilgore, who was notified of the incident immediately, said on Monday in a phone interview, that it appeared someone entered the building through the basement.

"Many people's first thought when we realized there was minimal damage to the building was how much damage was done to the organ," Kilgore said. "Right now, we still don't know. Thankfully, Peter is an employee of Parsons Organ Builders Company in Canandaigua so we will have them come out and take a look at the organ."

Kilgore stated that the Lima Farmers Market was still going to be held on the church's front lawn on Tuesday, August 25, as originally scheduled. Plans for worship on August 30 have not been made.

Fire investigators tentatively attribute the fact that the fire did not spread due to the quality of the old oak furniture and floorboards, Kilgore stated. The fire was small but it threatened a significant local landmark. Kilgore also expressed his thanks to the firefighters, the ambulance personnel and the sheriff's deputies and Livingston County Fire Investigators from the County Emergency Management.

The church, organized in 1795, is the oldest Presbyterian Church in the Genesee Valley Presbytery, which encompasses 61 churches in Rochester and a surrounding five-county area. The current church was designed by John Rochester Thomas, a Rochesterborn architect who had a prominent career designing buildings in New York City. It is in the Romanesque revial tradition as evidenced by the round, arched windows along both sides with

21 State Budget, we are concerned that this funding could be cut or lost all together if the federal government doesn't provide direct aid to state and local governments as part of the next stimulus package," said NYSAC Executive Director Stephen Acquario.

The resolution notes that programs funded through Cornell University's College of Agriculture and Life Sciences, including PRO DAIRY, have helped farmers to safely dispose of dumped milk during this time and provided quality information from economists on where the milk market is headed.

Throughout the pandemic, Cornell's College of Agriculture and Life Sciences has also provided many services to our farmers, including weekly online seminars on food safety, virtual meetings that explain how to best adopt social distancing on farms, and bilingual educational materials to reach the farm employee community.

"These programs have been a win-win for both New York farmers and residents, but this successful partnership is at risk if Congress doesn't reach an agreement that provides desperately needed aid to state and local governments that have been devastated by the pandemic and resulting recession," said Acquario.



A year ago last month, the Rayson-Miller American Legion Baseball team, which featured 2018 Honeoye Falls-Lima graduate **Owen VanNewkirk** and 2020 HF-L grad **Hayden Smith**, was playing in the New York State American Legion baseball tournament in Utica. The District 7 champions wound up bowing out of the tournament after four games and, while the squad would have featured some new faces this summer, it was hoped that they could have been a contender for the District 7 title again.

Then, COVID-19 struck and the National American Legion Baseball decided to scrap the 2020 season. It was tough pill to swallow for local American Legion baseball players, coaches and fans. This summer, Rayson-Miller was going to feature three HF-L players, Smith and fellow HF-L Class of 2020 graduates **Tim Martin** and **Riley Wall**.

"Those three boys would have definitely played for us," longtime Rayson-Miller manager **Tom Sapienza** said. "We might have had another player from HF-L as well but I stopped recruiting for the team at the end of March. We had great hopes for being competitive again this season even though the roster had turned over somewhat."

Sapienza said that Smith would've been a big hitter for the team as well as a top pitcher and playing infield on days he wasn't pitching. Martin could've helped the team as a pitcher and Wall would have played some second base, giving the team another reliable infielder.

"Both of them were highly regarded and recommended by HF-L Coach **Dan Hoyt** and Hayden helped recruit them just as he was recruited by Owen," Sapienza said.

Other players back from a year ago were **Jesse Countryman** (Avon Class of 2020), who would have pitched and played infield, **Ian Read** (Avon Class of 2019), **Anthony Puma** (Pittsford Sutherland Class of 2020), **Donny Varrenti** (Pittsford Sutherland Class of 2020), **Colin T. Smith** (Pittsford Mendon Class of 2020) and **Grant Rodriguez** (Rush-Henrietta Class of 2019). **Vinny Mason** (Aquinas Class of 2019), who did not play in 2019 due to an arm injury, was also scheduled to return to the team this summer.

# Mayor, Supervisor Weekly Update Sales Tax Update, School Tax Update, & DPW Projects

#### Village of Lima

John Correll, Mayor:

"The water tower project is underway and the tank is now offline. The pump station is keeping pressure steady and being closely monitored. If you have any water issues please call the village office at 624-2210."

"Route 15A is scheduled to be micro-paved. The sides of the road will be coned off, if you park on the side of 15A please do NOT park there until the paving project is complete."

"Fall isn't far away. Fall leaf and brush pick up are on the Village website (https://villageoflima.us/) and will be in the newsletter."

#### **Town of Rush**

Gerald Kusse, Supervisor:

"Everything in Rush is pretty nice. You would expect that, because we are the best kept secret in Western New York!"

"We do have some challenges. We can start off with the sales tax share which was significantly less than we had expected or hoped for. But we understand why it's happening. We're going to work around it and do what we can to go without this time."

"In terms of other things, I just said to someone on the phone, a little earlier, "We've got to hope that our restaurants open up soon because, while they do offer dining right now, it's outside and if a ring cloud were to come over, you'd have quite a bit of water with your food. That's not something to look forward to."

"Our Town Hall has opened as I stated in an earlier meeting last week. We haven't had any incidents whatsoever. We've got sanitizer, masks, etc... at the entry door and it's being used. We've got markings on the floor for social distancing and we just haven't been inundated with customers. We've had what I would call a light steady stream. If that keeps up that'll be fine with me. Our library will probably open, maybe next week, if not the week after. And there's a lot of people looking forward to that. I wish we had a bunch of restaurants that were waiting in the wings to open, but we don't have that."

"We're still waiting to see what the impact of the school opening will have on our recreation programs because we do have after school programs that care for children and we're waiting to see what will happen when the school gets ready to implement their plan for reopening."

"The pavilion behind our town hall is available for people who want to make reservations to use that on any day of the week. It's been very popular in the past, and we hope the popularity will spike up again once people are comfortable with getting together in a social setting. We've got a limit on the number of people who can go in there right now, but we are hoping for the best and hoping the spikes that we see in other sections of the country do not come back in beautiful downtown Rush."

#### **Town of West Bloomfield**

Todd D. Campbell, Supervisor:

"There's nothing new/major happening in town. We will be having a meeting on the 27th regarding the reorganization of the Rural Cemetery. All lot owners and interested parties are encouraged to attend on August 27th at 7:00 PM at the Town Hall. We had our first in-person Planning Board meeting last week and look forward to having more in-person meetings in the coming months."

#### **Village of Scottsville**

Eileen Hansen, Mayor:

"Well, things are going well, things are pretty quiet. The North Road project is still going on. They've been paving this past week. We have a section of North Road that's paved between probably the railroad track and the high school. They're working on that and they'll be moving on to the next section from the railroad up to the light. They still have to put curbing in there, do all that prep work up there, and then I know they're going to be doing entrances to driveways, the shoulders, the sidewalks, everything will be coming up. It's a long project, but it's nice to see some new paving on the road."

"Regarding the Oatka Place sidewalks, our DPW has just finished pouring cement. So, the sidewalks are in, the forms are out, and now they're moving on to topsoil seeding and driveways to repair them. They should be finished with that project in the next week or so. After that they're going to move on to the drainage issues that we have in the village on our easements. We have a couple of easements that need drainage work. So the DPW will be moving on to that next."

"In terms of the Fire District, we are in that period for permissive referendum. We haven't heard anything as of yet. If there is no permissive referendum by September 4th, then our fire district will be in place."

"We also took a sales tax hit like everybody else. Our sales tax was about 20% lower than the same period last year. Hopefully, we are going to be able to weather this. In our budget last year, we have had two retirements. That has helped us a bit as two of our senior DPW workers retired near the beginning of the year. That gave us some leeway in those salaries. We have traditionally under budgeted revenues from the sales tax. So, when we increased it for this year, it probably was still under budgeted. We're hoping that will help us in weathering the decrease in sales tax revenue. So things so far are look-

"We have a village election coming up. We have openings for two Trustee seats. That election is going to be held September 15th at the Municipal Hall. People should wear their masks, file through correctly, and come and vote."

"For the library. I have not gotten any indication of when they're reopening. They're still doing curbside service, but I will check and see if they have any plans for reopening in the near fu-

"As for our Pavilion in Johnson Park, that is still closed. We've decided to kind of wait and see how school reopening does and whether there is any spike with the school reopening before we start reopening the Park for rental of the pavilion. So we're waiting on those things. Otherwise, things are quiet."

#### Village of Honeoye Falls

Rick Milne, Mayor:

"It's good to see everybody. The Village of Honeoye Falls, the true front gate to Monroe County, we're always happy to be here. You know, really, not a lot new from last week's call overall. We were very pleasantly surprised by our sales tax. We're down, and that's always a negative, but it was only by around 15%. That's a positive in some ways."

"I have reached back out to the County Executive's office really on behalf of all the villages. We talked about this on a village mayor's meeting just last Thursday evening. We had a Zoom meeting with our county group and I've asked for the formula, if you will, of how that sales tax is all broken down. I know we've been given that, you know, I think a couple County Executives ago. I think I remember seeing that information, but people ask how come one village or town is down you know 20 or 30% versus another one that's only down 10%. So we're going to try to make sure we have that information to explain that. But again, we were pleasantly surprised with that negative, if you will."

"Our last concert is this coming Tuesday, August 25th. Again, those have gone very well. Even with a little rain burst we got this past week, people still hunkered down and stayed and listened to some great music."

"Supervisor Moffitt had mentioned the roof projects they have going on. In conjunction with the Town of Mendon, our partners with the Honeoye Falls Volunteer Ambulance, we're looking at that roof for their facility now to start to get some quotes and have people look at it. That's a joint effort between the Town and Village to keep that building up and that service running positively. So again, our thanks always to the Town of Mendon for their partnership."

'The last thing I wanted to mention, and this is something that we just found out about this past week, but it is some very good information. The Honeoye Falls Fire Department has just been awarded a FEMA grant for just under \$160,000. This will be broken down, approximately \$152,285 will be awarded by FEMA and then there will be a 5% match from the Village, (so that'll be approximately \$7,614). This is for the purchase of 22 new air packs or "SCBAs" as they're known as. These will be for all of our trucks and all the jump seats and all the seating positions for the truck. This is a huge win for the fire department and for our communities. Overall, that's a couple hundred thousand dollars in savings that we're getting through this FEMA grant. Kudos and our hats are off to Chief Hood and his team and Brian Anderson, our Village Administrator who was involved in that. They worked with a great grant writer and we're just really excited to be able to make this announcement. That's a good win for the community!"

#### Town of Mendon Moffitt, Supervisor:

John Moffitt, Supervisor:

"As I mentioned in other weeks, we are open for business at Town Hall. We do have all the CDC protocols in. We are seeing an influx of people for various things: hunting licenses, fishing licenses, marriage licenses, and various items regarding applications."

"Also, school tax collection will begin shortly, because the school tax bills will be coming out. For all residents of the town of Mendon, we collect school taxes, including the residents who are in the Pittsford School District, because there are numerous parcels in the Town of Mendon that are in the Pittsford School District. We do collect school taxes for all residents, including obviously the Village of Honeoye Falls."

"We are coming out with instructions because the county executive came out with some information on paying school taxes via credit card without having to pay the 3% fee for the credit cards. That is done through the county's website, so we have information on that. That's going to appear in the *SEN-TINEL* as well as our Facebook page. Residents can pay their school taxes online, town of Mendon residents, at least, and we can reduce the foot traffic at Town Hall due to the pandemic."

"We, as everyone else, are talking about sales tax. We had a shortfall of Town of Lima

about \$60,000 in our second quarter. We are working on our budget and will absolutely be taking that information into consideration."

"We have the roof projects going on, which we're getting closer to the starting point, which are on our Community Center and Legion and two buildings at our highway department. We had a pre-construction meeting yesterday, so those are progressing. We also expect to start on our electric vehicle station at the Mendon Public Library probably within the next 30 days."

"For our comprehensive plan, we have a zoom meeting regarding public participation in our Comprehensive Plan, which will take place on Tuesday, the 25th at 6pm. I encourage residents to participate. There will be time for public participation at that Zoom meeting."

"As I mentioned last week, the library is open. They have some specific guidelines, so you should check the library's website for those specifics before going to the library, but they are open for business."

"Things are starting to look up a little bit. I've seen more and more people out and about. Certainly, with summer winding down, I'm sure everybody likes to get out and outside and enjoy what we have left of some pretty good weather."

# WHAT'S IN A NAME?: DRINKS ARE ON US

For the past few weeks, we've been offering up samples of our third book which is currently in the works. In this book called, What's in a Name? we travel the world looking for places that have unusual and intriguing names and tell the stories behind them. This week we're going to belly up to the bar for some fun and games and here's how we play. We will share true stories about real places wrapped around the theme of drinking.

Why don't we head down to Whiskeytown, find out how Beer Bottle Crossing got its name, and perhaps even more curiously, how does the town of Toad Suck have a name that's based upon the consumption of alcohol? The answer to that one will leave you feeling a little green.

#### ONCE BREWED, ENGLAND & TWICE BREWED, ENGLAND

These are actually two separate towns which are located right next to each other and share an intermingled storyline where, in the name game, one moniker plays off the other. As fate would have it, Twice Brewed was first named. Here's that story.

TWICE BREWED - In 1751 a road was being built across this area in central England and the workers stopped into the local tavern to collectively quaff some pints of ale. Everyone complained that the ale wasn't strong enough and urged the innkeeper to "brew it again." The rest, as they say, is history with Twice Brewed becoming the name of first the inn, and then the town.

ONCE BREWED - Now, sally forth almost two centuries to the neighboring town where a new youth hostel was being opened in 1934. The owner was a teetotaler named Lady Trevelyan, and during the hostel's dedication speech she observed that it was uncomfortably close to the Twice Brewed Inn. "We will serve nothing stronger than tea," she said. "I hope even that will only be once-brewed." And again, the rest is history.

Playing upon the uniqueness of their names, combined with their proximity, the twinned villages feature some signage that salutes their situation. There is a single billboard between the towns, and travelers heading west on Military Road will be hailed by the greeting "Welcome to Once Brewed." Coming from the other direction drivers will see "Welcome to Twice Brewed" on the other side of the same sign.

#### BEER BOTTLE CROSSING, **IDAHO**

This picturesque spot is located near Boise in the southwestern part of the state. The location is near a scenic view overlooking a lake and it is this natural beauty that indirectly led to the unique name.

Because of the setting being both serene and secluded, it became a hangout spot for the local party people who were known to fire up a few joints and throw back some cold frosty beverages by these crossroads.

When local clean-up crews would make the morning rounds, the smell of the weed would have wafted away, but unfortunately still remaining would be the empty bottles, the "carry in carry out" directions being sometimes ignored. Hence the name.

#### WHISKEYTOWN, CALIFORNIA

Today, Whiskeytown rests at the bottom of a shot glass, so to speak. In 1962 Whiskeytown Creek was dammed to create Whiskeytown Lake. So what was once a bustling mining town in the 1800's was intentionally

#### THE BOTTLE, ALABAMA

Imagine it's 100 years ago, you're driving through rural Alabama, and up ahead you notice a bright orange 64foot high wooden soda bottle looming on the horizon. What do you do? Well, let's face it, if it were 100 years ago and you were driving through rural Alabama in the first place, it's probably a pretty safe assumption that life has not dumped you in the lap of luxury.

You have not traveled the world and you haven't seen it all. So what do you do when you happen upon literally the biggest bottle in the world? You bet your homespun country butt you're going to stop and check it out.

Hey, bigger names than yours have been lured in. The honor roll of visitors to The Bottle ranges from the sublime to the sophisticated. Grand Ole Opry singer Minnie Pearl stopped by to set a spell and President Franklin D. Roosevelt once ascended the second floor balcony to deliver a speech.

The Bottle is located sixty miles northeast of Montgomery, near Auburn University. The original bottle was built in 1924 by John F. Williams, owner of the Nehi Bottling Company, with the intention of garnering a bit of roadside publicity. In addition to that purpose, it also contained a grocery store and a service station in the bottom, and became a popular meeting spot.

**SIZE OF THE BOTTLE** ~ Here are the complete stats on the bottle's physical dimensions. In addition to standing 64 feet tall, the wooden structure measured 49 feet in diameter at the base, and 16 feet in diameter at the cap. Above the service station

flooded to create a community of area, which was outside of the bottle, was a balcony deck that was used as a gathering spot and party area. Above the ground floor grocery store, the second and third floors were living quarters and storage respectively. There was a spiral oak stairway running through the neck of the bottle which had windows enabling it to be used as an observation tower. The bottle cap served as the roof.

Unfortunately the reign of the bottle would last for but a scant dozen years. The Bottle lost its bottle when it burned down in 1936. The visual of that event must have been spectacular with the giant orange bottle engulfed in giant orange flames.

Went up in a burst of orange flames Although the structure no longer exists, an historic plaque and a photograph mark the location, and Alabama maps still list the area as "The Bottle."


#### TOAD SUCK, ARKANSAS

Located on the Arkansas River in the central part of the state is Toad Suck, Arkansas, current population zero. Oh, but there was a day! There are two competing theories as to the origin of the name. We'll do the worst first. As we have a little fun with rhyme there, let us clarify that statement by saying that Theory #1 is not weak in terms of credibility. The two theories are probably equally viable; Theory #2 is just a lot more fun.

Theory #1 ~ This scholarly approach bases the name upon the fact that the first Europeans to thoroughly explore the area were the French. It espouses the theory that Toad Suck is a corruption of a French phrase meaning "a narrow channel in the river."


