
Six Alumni Inducted Into HF-L Alumni Hall Of Fame This Weekend

Six new inductees will join the Honeoye Falls-Lima Alumni Hall of Fame in a ceremony as part of the district's Fall Weekend activities.

Following are biographies of each inductee

ERAZIM KOHÁK

Honeoye Falls High School
Class of 1950



Renowned Czech philosopher, Erazim Kohák, is an exemplary role model in his tireless effort to preserve democracy and the planet.

At Honeoye Falls High School, Kohák demonstrated a very inquisitive mind and was eager to learn. He took courses that challenged him, particularly in math and science. He grasped concepts quickly and made many friends easily. His zest for learning put him in the upper percentile of his class. He did manual labor to help pay for his education at Colgate University where he received his B.A. in Philosophy. Granted scholarships, he was able to continue his studies, receiving both his Master's and his Ph.D. from Yale University.

He served in the US National Guard and went on to teach thousands of students, first at Gustavus Adolphus College and then at Boston University. In 1989, after the fall of the Communist regime and at the invitation of then-President Vaclav Havel, Kohák returned to Prague to teach at Charles University. There he contributed to the re-establishment of Czech philosophy and tried to arouse ecological awareness. From

1990 to 1995, he split each academic year between Boston University and Prague's Charles University before returning to Prague permanently.


Kohák authored many books and had almost five hundred publications to his name. In his writing, he focused on Czech philosopher Jan Patočka, democracy, and its values, and environmentalism. A passionate activist, Kohák was heavily involved in Boy Scouts and his church. He was a member of the American Metaphysical Society, a member of the honorary board of Children of the Earth, a member of the Society for Sustainable Living, and was active in the Social Democratic Party as well as many non-governmental ecological organizations. He was elected by the Czech Parliament to serve on the Czech Television Council, overseeing public television programming.

Kohák received numerous awards and accolades, culminating in 2013, when the President of the Czech Republic honored him with the country's highest civilian award, induction into the Order of Tomáš Garrigue Masaryk, for his "outstanding contributions to democracy, humanity and human rights" in the Czech Republic.

Kohák passed away on February 8, 2020, in his hometown of Prague. As a philosopher, he will be remembered for his warning of boundless consumerism and calling for a more equitable distribution of wealth. As he put it, "At present, the ecological problem is a social problem of poverty and abundance. The antibody against wealth is solidarity." As a man, he will be remembered and missed for his love of life, his humor, his generosity, his cosmopolitanism, and his thought-provoking conversation.

FRANK OPPEDISANO

Honeoye Falls High School
Class of 1952



Frank Oppedisano's Honeoye Falls school days were filled with academic success, activities, and athletics. An honor student, an active member of

Student Council, Press Club, Athletic Association, Chorus, and the Senior Play Cast, he also attended Boys' State and was Senior Class Vice President. One of his classmates describes him as an excellent athlete, wearing the Orange and Black uniform for the Hornet's baseball and basketball teams. He also played soccer, basketball, and baseball on Honeoye Falls' "town teams" competing in county and regional leagues.

Following three years of military service as a United States Marine, Oppedisano enrolled at Alfred State Technical Institute graduating in 1960 from their Refrigeration Program, with specialization in air conditioning, heating, and refrigeration. His college years included the Psi Omega Fraternity, the Alfred Society of Refrigeration Engineers, and athletics. He co-captained the basketball team that won the first Region III Championship in Alfred State history.

In 1974, he embarked on his career with Postler & Jaekle, a Rochester-based mechanical contracting company, and never retired. According to Beth Howard, Principal/CFO at P & J, "During his tenure at the company, Oppedisano held multiple roles at the VP level, with functions ranging from engineering to construction execution. This allowed him to perform various duties, including sales, estimating, project management, design-build, and value engineering. "We are very appreciative of having Frank in our lives for 40-plus years. He was selfless with his time in teaching others, so we thought it would be fitting to have him memorialized through a scholarship where he can continue to help others grow." After his death, the company paid tribute to him by making a generous donation of \$50,000 to Alfred State to create the Frank Oppedisano '60 Memorial Endowed Scholarship.

Across 53 years of marriage, Oppedisano and his wife Paula raised three children: Mary Beth, Paul, and Daniel, all HF-L graduates, and welcomed three grandchildren.

Oppedisano was always ready to assist. He was a life-long member of St. Paul of the Cross Church, sharing his professional skills with consults and repairs to buildings and grounds, and assisting with Parish events and fundraising. He was a member of Honeoye Falls, American Legion Post #664. He was a value-added member of Honeoye Falls Village Government serving appointments on two boards and then as an elected Trustee on the Village Board.

Oppedisano lived his life

contributing to his schools, his home community, his profession, and the country. He lived a humble lifestyle filled with family, service to others, and a steadfast eye on "paying it forward." He is an exceptional role model for students.

JOHN NEENAN

Lima High School Class of 1965



For a man who enjoys working with the soil, John Neenan is an excellent example of blooming where you are planted. Whether it's personal matters, business, or community giving, Neenan's accomplishments are a testament to his high morals, citizenship, caring, and respect for other people. Besides that, he's pretty darn tough. He's been beaten down by a bull and has recovered to tell the tale.

Neenan was a busy guy while at Lima High School. He was a four-year baseball and basketball standout, president of his sophomore and senior classes, vice president of his junior class, an active member of Student Council, even serving as Chaplain of Student Council. After earning a Regents Diploma in 1965, he went on to obtain a degree in Agronomy from Alfred in 1967.

Neenan and his high school sweetheart, Sharon, raised three

successful children; Kevin, Traci, and Brian. From the beginning, he always took an active role in his kids' lives. Neenan instilled in them a strong work ethic and moral character. He was their coach in the early years of their sporting lives and an enthusiastic spectator later. He continues that tradition by cheering on his seven grandchildren at their various events. Recently, Neenan was recognized for scorekeeping at HF-L games for over 25 years.

Neenan's Farms is an award-winning business that is well known for the quality of its livestock and crops. They've accomplished this through hard work, intelligence, and willingness to try new innovative approaches. In 2008, their farm earned the Livingston County Commerce Award for "Farm of the Year."

One example of Neenan's commitment to his community is his work on establishing and building Mark Tubbs Park. He assisted with everything from land surveying, obtaining construction materials, grading, seeding, building basketball backboards, and constructing baseball dugouts.

Friend, Ralph Clapp states, "John is committed to his community and he is always looking for ways to support the people around him."

Neenan has been a lifelong member of the Catholic Church and has served as Altar Boy, Choir Member, Eucharistic Minister, and Trustee at St. Rose Church in Lima. He currently attends Mendon's St. Catherine's Church with his wife and extended family.

Nothing stops Neenan. Active at the farm, in the fields, and a multitude of sporting venues, he's proven himself to be a man for others and a force to be reckoned with. That bull may have tried to take him on, but Neenan had faith, worked hard, and carried on.

HF-L reports COVID cluster at Manor School; Wheatland-Chili also has cases

The Honeoye Falls-Lima Central School District reported an outbreak of COVID-19 at the Manor School last week.

The outbreak or cluster was reported on September 20. The district reported that due to the outbreak, one classroom was shifted to full remote for 10 days. The students diagnosed are being kept home from school until they are no longer infectious and parents of all students known to have close contact have been notified and instructed to keep children home. Staff who were in close contact and who have been vaccinated have been offered routine testing and support. Those staff members who are unvaccinated but who were determined to have been in close contact were also placed in quarantine. As of September 20, three students at the high school were in quarantine, three at the Middle School and 12 at Manor School.

If parents have not been notified

by either the school district or state, it is believed that their children were not in close contact with those children.

According to the New York State School Covid Report Card on September 24, HF-L reported the six students at Manor had tested positive, one student at Lima Primary had tested positive, one Middle School student had tested positive and one high school student had tested positive.

In the Wheatland-Chili school district, the state report card on September 24 stated that there was four students testing positive at TJ Connor Elementary School and two students testing positive at the Junior/Senior High School building. In addition, there was one staff member at the Junior/Senior High building testing positive but no teachers had tested positive.

North Bloomfield document found in Honeoye Falls-Mendon Historical Society archives

As our series on the hamlet of North Bloomfield culminates this week we have unearthed one vintage history written by one of the hamlet's notable statesmen from back in the 19th century. Actually, to give credit where credit is due, we should say that the document we are about to share was unearthed by Charles Woolover and Bill Lane of the Honeoye Falls-Mendon Historical Society.

All of this serves as a reminder of the unique geographical umbrella under which the Town of North Bloomfield falls. Why don't we go back to the very beginning of our involvement with this project and connect all the dots for you. It was actually November 13, 2018 when we started working on this project by attending a meeting of the West Bloomfield Historical Society where the topic was the hamlet of North Bloomfield. This was where we were able to connect with our old

schoolmate Doreen Sensenbach Haller whose North Bloomfield historical roots run deep.

This begins to focus attention on the question of where exactly North Bloomfield can be found and once you're there, what town would you be in? There are multiple possible answers to that question and in order to fully explain this somewhat unusual phenomenon, let us fall back on something we wrote in the first installment of this series to fill everyone in on the location.

HOW TO GET THERE ~ We'll use the four corners of Honeoye Falls as our reference point. When you get to the light, turn whichever direction you need to turn in order to take East Street across the Honeoye Creek bridge, admiring the falls off to your right. But don't gaze for too long because just after you pass the Village Hall you're going to take an immediate right onto Ontario Street (Route 65 South). At this point you are only about a mile from your destination, but between here and your arrival be prepared to experience a quirky geographical phenomenon.

Continuing in a southerly direction on this same road, you are about to find yourself in three separate counties within a span of a couple hundred yards. After you pass over Honeoye Creek yet again, you'll soon see the sign signaling that you are entering Livingston County. Welcome to the Town of Lima.

Within a few hundred yards, after you pass Ideson Road on your right, you'll see the sign showing that you are entering Ontario County. Welcome to the Town of West Bloomfield and the hamlet of North Bloomfield.


Continue straight until you come to the next quirky intersection. We say quirky because the intersecting roads heading east & west are not exactly opposite one another. You can turn right onto Martin Road or go another twenty feet and turn left onto Quaker Meeting House Road. If you were to turn right onto Martin Road at this point you would find yourself on what was, back in the day, Main Street North Bloomfield.

Based upon the geography lesson we offered above, when you make that turn onto Martin Road you're in the Town of West Bloomfield (Ontario County), and if you continue west down the road you soon find yourself in the Town of Lima (Livingston County). But in terms of proximity to a population center, North Bloomfield was closer to Honeoye Falls (Monroe County) than any other village resulting in the unusual circumstances that this hamlet which was geographically split between Ontario and Livingston Counties had its greatest sense of community with the Village of HF in Monroe County.

So circling back around to that first meeting we attended in 2018, all of this would explain why the Town of West Bloomfield would be hosting the meeting on North Bloomfield. It would also explain why the West Bloomfield historian Pat Talley told us to "look in

SMITHS' LISTS CHRIS BERMAN'S 25 BEST NICKNAMES

Chris Berman established himself as an American icon in the world of sports broadcasting after he began his career at ESPN in 1979. That was the year that the fledgling network launched and Berman was installed as host of ESPN's *SportsCenter* which, to this day, remains its flagship show.

From the beginning, the success of ESPN was built upon the basis of its ability to use humor to enhance its coverage of sports. To this end, Berman became ESPN's ultimate vehicle. We have an upcoming book called *Listing Dangerously to the Left* where every component is written in the form of some kind of list.

The single aspect of Berman's career that most lends itself to this *"Listing"* project is certainly his hysterically groundbreaking shtick of wordplay with nicknames for the athletes about whom he would be reporting. How it worked was that he inserted fictitious middle names which, when combined with the real first or last name, played upon established catch phrases or clichés.

So we must offer this list with a caveat based upon the fact that Chris Berman hosted *SportsCenter* from 1979-1990. Subsequently, the athletes to whom he refers, as well as the pop culture references which make them resonate so resoundingly, are all based within that timeframe. We will supply the additional information we feel necessary to prove this piece timeless.

There are literally hundreds of examples of Berman employing this technique and we are going to share with you here our Top 25. Honing hundreds to dozens was indeed a challenge and we found ourselves resorting to a two-pronged process. We favored the more prominent athletes who might still be known to readers today. Also some of the catch phrases were expressions that trended during the 80's but subsequently passed out of usage rendering the shtick less impactful on a modern-day audience.

So that being our process, we hope you enjoy the list we have compiled.

#17 ~ Jeff "Brown Paper" Bagwell (Astros first baseman)

As I sat in the pews of St. Catherine's last Friday morning, I couldn't help but admire the courage and clarity of Andrew Boyce and Conner Boillat as they described and honored the very full life of Mike Francesco.

Mike touched the lives of many in our little neck of the woods, even those who may have never known him. He, together with his late son Michael, Jr., conceived and built what has become the hamlet of Mendon's community cornerstone.

For almost four decades, I was one of those who was blessed to have experienced the wonder of Mike. While I can't pretend to offer more than his family, I can share memories – and, more importantly, the context of those memories – that affirm their stories from a non-family perspective.

I met Mike and Rose in the mid-1980s shortly after I moved back to Mendon in the house I still live in. I wasn't married then, still in my twenties, and was generally a quite busy fellow, a solitary bachelor dwelling within a family-sized home.

Technically, I wasn't living alone – my brother and his young family lived with me for a short time until they could settle in their own home. Following them, upon her graduation from the University of Buffalo, my sister stayed with me until she found a job in Albany.

Still, realizing their companionship was only temporary, I was interested in meeting my new neighbors. In that quest, I began transitioning from the wider groups in which

I was active in to some Mendon-based organizations.

I can't remember the very first time I ran into Mike and Rose – and for me, the two were inseparable – it could very well have been at St. Catherine's Church. I do remember they immediately took a keen interest when they discovered I had lived in Chili attended the same school as their kids

(my brother Kenny was in their daughter Karla's grade).

I will say this, though, the "keen interest" was mutual. I couldn't help but see hints of my own family, my own heritage, in Mike and Rose Francesco. Rose especially. She looked and spoke like my mother's mother. Same kind of homespun wisdom, too. Mike, while a different size and shape, had that same little "knowing" twinkle in his eye as my grandfather.

Through the years, we'd see each other every Sunday at St. Catherine's. As my own family blossomed Mike & Rose took an equally keen interest in our kids, always wanting to know what they had done lately. Always insisting we reveal the latest tale of their lives.

Returning to those early years, besides Church, I also became active in the Rotary Club and the Mendon Republican Committee. Both had me out and about in the community and I would regularly see Mike and Rose.

What I recall most, however, were my door-to-door canvassing with party petitions. This is where I really got to know my two neighbors. Here's the funny thing:

these were usually "in-and-out" activities. Knock on the door, say hello, get a signature or two, then move on to the next house.

But not when I got to Mike

& Rose's house. Sure, they'd sign right away, but then they'd insist I come in and talk. I couldn't say "no." And it wasn't just out of respect. I actually looked forward to these visits of shared comradery. I felt like I was "going back home" to visit family. In exchange, they seemed to enjoy my storytelling.

One of the many stories I would tell them was how impressed I was with their family campus – a group of three homes set back off of Route 251. Besides them, their two adult children and their growing families lived there.

It was a dream of mine to one day have a similar arrangement with my own family (remember, I wasn't yet married – I didn't even know Betsy at this point – but it didn't mean I couldn't plan ahead). Keeping the family close has always been the ideal. I told them I know a perfect place (in Chili) to build my family homestead. It already featured a line of tall trees on each side of an existing private road.

Mike laughed when I revealed where it was. I quickly joined in with a chuckle because I knew what he knew. This land was in a regular floodplain of Black Creek. No one would ever

want to build a house there.

Most of the stories were one way: me telling them about my family experiences. They rarely spoke of their own experiences.

They asked a lot of questions and I was only too happy to regale them. And I could see by the genuine smiles on their faces that they were equally happy hearing them. Perhaps, I thought, I was

rekindling their memories of times past just as they were doing for me.

Mike and Rose didn't have to use words to communicate, though. Their actions spoke much louder. Rose's constant hospitality (I swear I gained weight every time I visited) vocalized volumes. Mind you, she was also an entertaining speaker, too, always and never afraid to tell it like it is.

With Mike, it was a couple of things. First, there was that twinkle in his eye. It said more than anything. From "I've seen a lot, so I know what you're saying" to "I get what you're not saying and am glad you trust me enough to not say it."

More significant, though, and echoing my own family's history of "father and son" building partnerships, was his working with his son Michael on Mendon Square. I had followed that development since the beginning.

Wait! That's where I first met Mike! I just remembered!

I needed fieldstone for landscaping the front of my house when it was being built. My brother and I had collected a large pile from around the house. It was quite a mass, the first of which was used to

build the fireplace in my family room (built, by the way, with my grandfather and father with me and my brother finishing it off).

Well, when the house was finished and before the landscaping was started, I came to the house one day only to discover the land had been graded and all that fieldstone collected by me, my brother, and my friends was gone! In a bind, I needed to find where I could get more fieldstone. Then it struck me.

They had just started digging several foundations on the Mendon Square project. (For those not familiar, this is Assembly Drive in the hamlet of Mendon.) I convinced my brother to bring his old beat-up truck. That old Ford, wearily weathered when my father and brother teamed up to build the family's first Mendon homestead on Dixon Woods, was reminiscent of the same pick-up my grandfather and father had in their "Carosa & Son" masonry business days.

You see why Mike's working with his son meant so much to me.

Anyways, while scoping out geological specimens in Mendon Square, I found Mike. I explained what I was trying to do and asked him if it would be OK to take a couple truckloads of the stray stones we saw strewn along the freshly dug foundations.

Mike said, "Yes." He just didn't agree to let us take the stones. Both his words and that twinkle in his eye said he approved of what we were doing.

And that was the beginning of a beautiful relationship.

Last Saturday there was a whirlwind of activity down at Rochester Junction at the intersection of Plains Road and Junction Road. A 71-year accumulation of old paint, dust and dirt was cleaned from the roof of the Lehigh Valley Boxcar #62638. The crew of eight Mendon Foundation volunteers were then able to seal the perimeter of the roof with fiberglass embedded in layers of a high-tech epoxy roof coating. The next step will be to coat the entire roof with the epoxy roof coating.

Next the cleaning and painting of the entire boxcar will be undertaken, with the final step the stenciling of the LEHIGH VALLEY in big bold letters on the side of the boxcar.

The Honeoye Falls History Monument (Part II)

On Memorial Day 2006, while at Rush's Pine Hill Cemetery for a kids' event, News was giving an acquaintance a cursory tour of the grounds. While relating the Wilkinson search (initiated by those homeless gravestones back in Honeoye Falls), a pause along the main drive prompted "CHARLES WILKINSON" to be staring back at us.

Could it be...? Upon closer inspection, it was a "Eureka!" moment.

With *Charles* inscribed on one side, and his parents' names on the other, it seemed a tad eerie to find the Wilkinsons in this manner. It was there for everyone to see all along. A previous search, even with the help of the caretaker, not only failed to locate Charlie and his parents, it dampened the ardor to solve the mystery. With the discovery, the plot thickened and new theories were in the offing.

What must have happened was that the stones in question, ensconced for decades behind 43 North Main, Honeoye Falls, were created in the early

1890s. That's when Charles died in 1893, followed a year later by his dad (perhaps of a broken heart). When Mrs. Wilkinson passed on in 1902, stone maker Dennis Harris prepared to add date-of-death to his former neighbor's marker. Space was available for just that purpose.

End of story? Hardly. Unexplained was why one heavy stone, a few letters and digits short of an update, was replaced by another with less information but nearly equal proportion. With no surviving children, there were no clear-cut answers.

*Perhaps, with virtually indestructible granite rising in popularity, was it time for a "trade-in"? That was the dawn of the automobile age, and the American habit of trading-in "used cars" for new ones, at least among the moneyed class, was just beginning to bear fruit.

*Perhaps the use of the informal "Charlie," as noted on the original stone, was deemed too prosaic for a tombstone inscription...

*Perhaps adding Elizabeth's date of death could not be done without losing artistic appearance...

*Perhaps Dennis Harris, the monument guy with a penchant for granite, sweet-talked his former neighbor, the lonely widow Wilkinson, into a new model. After all, a key selling point was that, even with the passing of a few years, the mysterious composition of the original stone was stained by the elements. Conversely, granite was not as susceptible to the whims of Mother Nature.

Continuing this line of reasoning... at Elizabeth's behest, a revised *Last Will and Testament* may have read something like: "At my decease, Mr. Dennis Harris, Monument Maker, shall replace the family plot marker with one of Barre Grey Granite and engraved thusly....." Posthumously, Liz got her new stone, while, back in Honeoye Falls, when they toddled along a decade or so later, Dorothy Snoddy and her siblings and friends had a ready-made playground with a hint of cemetery


As Father Time trudged onward, subsequent owners pushed the variety of Harris markers toward the embankment of the race to the Lower Mill. There the stones languished, through decades of snow, rain, brambles and snakes, until the 1990s. In 1992, when Tom and Roseanne Judd, owners of 43 North Main at the time, informed the writer about their unwanted backyard collection, the era of the "History Monument" commenced.

Having spent the final months of his college days tromping around cemeteries in far west Kentucky, compiling a Master's Thesis on the historical implications of such places, this fish was hooked. The culmination of this yarn did not occur until several years later... in fact, nearly another thirty years have passed, and it may still be evolving.

In 2004, two years prior to discovering the newer version of the Wilkinson family marker in Rush, it was believed the stones in the bushes were legally anybody's for the taking. Coincidentally, the rumblings echoing out of "Surline (sic) Hollow," best known as "Rochester Junction," had News excited about his favorite place in all the world.

News was a member of the small army of volunteers bringing a once-glorious local railroad site into the brave new world of "Rails-to-Trails." That's a program where hundreds, if not thousands, of defunct railroad miles have been recycled into public thoroughfares for hiking, biking, birdwatching or just strolling.

Being one of the lucky ones to experience the last vestiges of Rochester Junction as a railroad place, an idea emerged... to make that grimy, green, two-ton mass of cemetery stone a tribute to the lore of two entities. The site would be a timeless ornament, not just a glitzy bauble, rather one that would inform, inspire and exude the rugged nature of railroading.



When being laid down in the early 1890s, the *Buffalo & Geneva Railroad* swept across the state, creating a point as it passed through the north portion of Mendon township where branch lines sprouted northward to Rochester, and south toward Honeoye Falls, Lima and beyond. Once up and running on September 1st, 1892, over the previous thirty years, the variety of incorporations intending to lay down tracks was head-spinning: *East Side Railway*; *New York, West Side & Chicago Airline Railroad*; *Rochester & Southern*; *Buffalo-Geneva Air Line*; *Honeoye Falls & Southern*; *Rochester & Honeoye Valley*; and, for a short time after it opened, the *Reading Railroad-Lehigh Valley Division* (the LV was working its way out of bankruptcy at the time). Once established, however, the public knew it as the line born of eastern Pennsylvania's coal region, the *Lehigh Valley Railroad*... with *Route of the Black Diamond* added for as long as its world-famous train rolled (1896-1959).

During the development of what has become the very popular *Lehigh Valley Trail*, remaining true to the memory of tracks and trains, bridges and depots, News attempted to entice project managers with his idea. Place the Wilkinson stone at the site of the former Victorian depot, he opined, with brass plaques touting the history of the Lehigh Valley Railroad on one face, and a timeline of the township's historic *Rochester Junction* on the opposite face. At two tons, no punks would make off with it, that's for sure.

Given the willies that it was once a cemetery marker, the "Rochester Junction History Monument" didn't fly with the Monroe County Parks committee. With the Wilkinson information ground away and plaques applied, this guy was befuddled. And besides, it begs the question: "How much different is it from memorializing the dead in a cemetery?"

HF-L football rallies to beat Wayne

The Honeoye Falls-Lima Varsity Football team hadn't faced this situation so far this fall, but found themselves trailing an opponent with just 1:42 left on the clock last Friday night (September 24). The Cougars kept their composure, however, and took just three plays to get into the end zone and pull out their fourth victory of the season.

HF-L beat Wayne 21-20 in the come-from-behind win.

The host Eagles got on the board first, taking the opening kickoff and driving down the field. Wayne marched 70 yards in eight plays, capped by a seven-yard run for the touchdown. The Eagles made the extra-point kick for the 7-0 lead with 8:45 left in the first quarter. HF-L drove from its 43 to the Wayne 10, but on fourth-and-9 missed a field goal just wide. Wayne maintained a 7-0 lead at the end of the first quarter. HF-L's defense stymied the Wayne offense the next time and forced a punt, which was downed at the HF-L 4-yard-line. Methodically, the Cougars' offense drove down the field. Utilizing a good mix of the rushing and passing games, HF-L advanced the ball steadily. Zac Meacham had a 15-yard run and an 11-yard run. Brody Young hooked up with Ben Carson for a 35-yard gain as Carson shed a tackler to gain much of that yardage before being brought down. Nolan Smith caught a 13-yard pass over the middle from Young. A swing pass from Young to Meacham on the right side resulted in a 15-yard touchdown that culminated the 11-play drive. Xavier Carbonel made the extra-point kick to tie the score at 7-7 with 3:57 left in the second quarter. The Cougars then recovered an onside kick at the Wayne 26 and Meacham ripped through a hole that the offensive line created to go up the middle for the 26-yard TD run. Carbonel made that extra-point kick to put the Cougars up 14-7 with 3:46 remaining in the second quarter. HF-L held that 14-7 advantage at halftime.

Wayne tied the game at 14-14 on a 69-yard run and an extra-point kick with 7:30 left in the third quarter and that was the only scoring in the period, setting things up for an edge-of-your-seat fourth quarter. The Eagles put together a 13-play drive

that resulted in a 5-yard TD pass. The Cougars, however, blocked the extra-point kick, which turned out to be crucial, leaving Wayne ahead 20-14 with just 1:42 on the clock. HF-L recovered the kickoff at its own 37. A screen pass fell incomplete on first down. Young then connected with JT Killenbec on a long pass down the right sideline and Killenbec got out of bounds at the Wayne 28, stopping the clock. On the next play, Young found Nolan Smith with single coverage on the right side and whipped a pass to him that Smith dove for and caught, the momentum carrying him into the end zone. The Cougars had used up just 22 seconds to get the TD. Carbonel made the extra-point kick to put HF-L on top, 21-20, with 1:20 left. HF-L's defense yielded a total of 11 yards on Wayne's final series before Hayden Meehan forced a fumble that Rhyan Garey fell on and HF-L ran out the clock.

"The touchdown to Nolan was originally designed to go to the left, but Brody saw Nolan in single coverage on the fade route and threw it. Nolan made a great diving catch," coach John Russ said. "We were concerned though because they had enough time for a last drive. We told the defense not to get beat deep, let them get 8-9-10 yards and try to keep them inbounds because they had no timeouts left."

Young completed 11-of-20 passes for 199 yards. Meacham carried 14 times for 93 yards. Killenbec rushed once for four yards. Killenbec had two catches for 48 yards, Aidan Goold two catches for 44 yards, Smith two receptions for 42 yards, Carson two catches for 36 yards and Meacham three receptions for 28 yards. HF-L had 296 yards of offense, running 41 plays, while Wayne had 318 yards on offense on 69 plays. Garey led the Cougar defense with 11 tackles, including a quarterback sack, and a fumble recovery. Jack Harvey had two tackles, including a sack. Meehan caused a fumble.

"We had only one penalty, so that was good," Russ said. "But, we need to be fundamentally sound as we had some bad snaps, dropped passes and a fumble when Brody got pressured on a pass. We have to clean those things up."

Clough's classmates remember her as an independent, gutsy, determined individual on the soccer, track, and cross-country ski teams. She even dared to petition the principal in 6th grade to allow girls to take shop instead of home economics.

Following graduation, Clough obtained an Associate's degree in Individual Studies (Architecture and Horticulture) from SUNY Delhi, 1982 and a Bachelor of Landscape Architecture (BLA) from SUNY Syracuse, 1985. She was licensed as a Landscape Architect in Massachusetts and New York. She followed her career path to New York City, Department of Design and Construction.

Clough had a prominent role in the "clean up" effort following the 9/11 terrorist attacks. The site was divided into four sections for management purposes and Clough was responsible for the southwest quadrant for the first three weeks. After that, she was responsible for the overall site logistics including much of lower Manhattan. In mid-October, as Clough was walking the site, she noticed that one of the mangled trees had sent up a couple of new leaves. She was inspired and heartened by this pear tree. Among all the rubble of death and destruction, this was a sign of "Hope and Survival." The tree was sent to the Arthur Ross Nursery in the Bronx where it flourished. The Callery pear tree stayed at the nursery until the 9/11 Memorial site was ready. It was moved and replanted in March 2010 and is known as the "Survivor Tree."

Clough's skills were quickly and often recognized, and she was promoted to more and more responsible positions. She led the way and broke the glass ceilings. Her considerable technical skills and knowledge are complemented and matched by her great management and people skills.

Over the past 30 years in NYC, Clough has worked and guided more than 900 projects ranging in cost from \$50,000 to \$1.5 billion; including police stations, fire stations, homeless shelters, correctional facilities, courthouses, parks, playgrounds, health clinics, and juvenile justice facilities.

In January 2019, Clough was promoted to Associate Commissioner for the Borough-Based Jails Program,





"As always, thanks for having me during this busy time."

"Unfortunately, one of our long-time residents Mike Francesco passed away on Tuesday. His daughter Karla Boyce is our current County Legislator. My sympathy goes out to the entire family. Mike was instrumental in developing many areas of the Town of Mendon, specifically the area where we have a large business district in the Hamlet. We certainly appreciate everything Mike did in this Town."

"I also wanted to mention that we will be having a joint meeting on Monday the 27th of September. That is when the Town Board will move the budget to preliminary status. We'll be setting a public hearing which probably will be on October 18. At that time after the public hearing, I would imagine we would move the budget to final status."

"The budget does include no cut services and a 10% cut in the tax rate. For those of you who are unfamiliar with the tax rate, I always say it's a math problem. You've got the total assessment, the assessed valuation, the tax rate, and that is what determines the amount of money that you pay in taxes in your town tax bill."

"Be sure to keep an eye on that and we appreciate any public input as that progresses."

"We have received our new speed signs. I mentioned this a few months ago that I saw them over in Farmington. So I spoke to Farmington. They've had great success. We have received them. There's quite a bit of software included, but we expect to have those up probably next week."

Elizabeth "Liz" O'Leary Rollins is a class act in and out of the classroom. Early on she was an inclusive team player and peer leader on and off the field, always providing comic relief when necessary. on the hill South of the brook. It was burnt, and the school was then taught in a log house of A. Martin's on the West side of the road near the road leading to H. Stanley's.


The summer of 1814 a school was built in the forks of the road west of A. Gate's. The first teachers in the new school were Chipman, Chadwick, Stephen Peck, Rhoda Kilbourn, Sarah Scofield (Mrs. Alanson Gates), Miss Peck, J. Dunshie, Moses Parmalee and I could mention several others. Joseph Hoyt and Ann Cummings were teachers in the school Sourh of Martins. A school was taught in a log house in the rear of the Lloyd place for a season or two. A school house was built in the rear of where N. Hutchinson now lives and was occupied several years. Some of the early teachers were Day, Conkline, Miss Parmelee (Mrs. W.F. Waite), Charlotte Leech and others.

In about 1832 a house was built opposite the Cemetery and about the same time one nearly opposite the old church. In about 1848 the two districts were consolidated and the lower part of the Church was arranged for school purposes and is still so occupied. The First Universalist preacher was perhaps Thompson; meetings being held in the house now owned by Mrs. Pierce and afterward in the school house. Perhaps Mr. Knapp was before Mr. Thompson but I think not. The brick Church was built in the fall of 1829, the brick being made on the flat below Mr. Chambers, Burton & Bond being the makers. The carpenter work was done by Benjamin H. House. I do not remember the mason builder. The new Church was built recently. I think I have written about enough for this one time and will let someone better posted of late than the writer of the foregoing and who can do better justice than I can, write of the later times.

About 1814 or 1816 Rice and Perry commence the manufacture of fanning mills in an old building where the intersection of roads now is at the lower mill. They carried on the business for a few years, then left and established the business at or near Lyons, Wayne County from which sprang the famous Lyons Mills. I will mention that while at North Bloomfield Perry left the firm and a brother of Rice's came. The firm was then Z. Rice & Co. Root & Cummings built a store on the site of the old shop which was removed on the laying out of the road to Honeoye Falls about 1826. Mr. Cummings built the dwelling now occupied by Robert Wiggins.

Stephen Peabody was sawyer at the lower saw mill about 1829 and a few years later he built a lathe for turning axe helve and also a machine for making rake handles and manufactured rakes to a limited extent. At quite an early day Jacob Smith had a distillery just North of the Harvey Jennings place. Francis Smith had one in the rear of the Lotee house across the race and a little above. It was in operation as late as 1818. Daniel Gates had one just West of where Alfred Gates lives which was in operation in 1810 and was run a few years. A Fourier Society was organized in about 1844 and flourished most of that year and went to pieces soon after.



HEADING SOUTH TO THE HAMLET OF NORTH BLOOMFIELD

GOIN' TO THE CHAPEL ~

On August 26, 2019, we met with Doreen Sensenbach Haller at the North Bloomfield Community Center. This building is just south of the intersection where Quaker Meeting House Road comes to a "T" with Route 65. That building is still adorned with a sign reading "North Bloomfield Chapel - Est. 1897." The church was built between 1895 and 1897 on land donated by Charles Hopkins. Doreen actually has the framed deed on display which she shares with us.

The meeting occurs on a beautiful August afternoon, and it is nice to drive into North Bloomfield and see the door to the old church wide open and waiting for our arrival. Upon entry it becomes easy to visualize ourselves in an old 1800's church. As we enter the front of the building, our gaze is immediately attracted to the original pulpit which lays straight ahead of us. That pulpit area is currently adorned with historical artifacts documenting the history of North Bloomfield.

This much anticipated meeting has actually been nine months in the making. While that may seem like a long time, it's actually not that unusual in our writing process. We have so many irons in the fire that it sometimes becomes excruciating and exhilarating at the same time.

The previous fall we had a rewarding reunion with our high school friend Doreen, at the November 2018 meeting of the West Bloomfield Historical Society. Our features in the *Sentinel* are already scheduled for so far in advance that we know at the time it will be 2020 before the article is published. So all of that being acknowledged, let us return to 2019 North Bloomfield and our meeting with Doreen.

MODERN DAY ~ Doreen shares with us the fact that their community building hosts three meetings a year of the North Bloomfield Community Association and one meeting a year of the West Bloomfield Town Board. This is in addition to the Memorial Day Parade and brunch event which we mentioned last week.

As the Honeoye Falls-Lima parade participants meander their way through the community, the order of the local parades starts with North Bloomfield at 9:30. One component of the North Bloomfield parade that differentiates it from the ones in Mendon, Honeoye Falls and Lima, is that the Town of West Bloomfield Fire Department also participates. After the parade the community returns to the North Bloomfield Chapel for a brunch with all participants bringing a dish to pass.

JOHN P. HALE ~ When we first started working on our North Bloomfield project in the fall of 2018 hamlet historian Doreen Sensenbach Haller provided us with copies of a newspaper series W.R. Hunt wrote in 1917 called "North Bloomfield in Early Days."

After having researched the history of North Bloomfield quite thoroughly, there was one storyline that uniquely emanated from the 1917 series and it featured perhaps the most irascible rascal raised in "them-thar" parts. The rascal went by the name of John P. Hale and he lived in the closest thing North Bloomfield ever had to a skyscraper. It was a three-story abode which accommodated a cider mill and woodshop along with his living quarters.

Apparently it was the ultimate 1840's party house, located by the bridge that crossed Honeoye Creek on what was called Main Street back in the day but is now known as Martin Road. Hunt

referred to the Hale place as a "beehive of activity." He was loved by adults and children alike and was known for allowing the local boys and girls to sneak sips of cider from a selected barrel under the pretense that the kids didn't think he knew. But John P. Hale knew all along.

Subsidiizing his sale of cider for sustenance, we mentioned that Hale also had a wood shop in his "skyscraper." In addition to carving out a nice variety of garden tools, he also fashioned an eclectic variety of woodwork ranging from clothespins to broom handles to other things too numerous to mention. Hale was clearly hell with a piece of wood.

Apparently, however, the one substance that appealed to Hale more than wood was gold. In 1850, Hale used his connections to rig up a prairie schooner, closed down his business, and set off for California. Compare this move to the modern-day ramifications of owning a three-story business and just leaving your place unattended to take a three-year tour across the country. Add to this the assumption that John Hale thinks he will return home to find his place totally intact.

At this point you are probably asking, "How the Hale could this possibly work out well?" As it turns out, John Hale's adventurism pays dividends. After his 1850 departure, he returns home in 1853 with a big bag of gold, and his three-story party house looks just the way it did the day he left it. And the good news is North Bloomfield's favorite son is back home.


Prior to Hale's California gold rush gig, he had been North Bloomfield's most popular in-home speaker and storyteller. Upon Hale's return, his celebrity soared and upon the insistence of the citizens, John Hale gave several public speeches about his Pacific passage and gold prospecting pursuits.

The only compromising factor hailing Hale's return was that he discovered the flow of the creek turning his water wheel had decreased to the point where his ability to run his cider mill and wood lathe had been compromised. Is Hale halted? Hell no! Let's herd the horses.

The ingenious John P. Hale devises a contraption whereby he can get a horse to walk on a treadmill and deliver the

power to drive the devices that can turn the wheels to keep his wood and cider mills operative and profitable. According to the 1917 series of articles, Hale could have made a fortune if he had taken the time and effort to patent his invention. For better or worse, Hale decided to spend his remaining time basking in the glory of his gold and sharing stories with the folks of North Bloomfield, rather than applying for a patent on his horse-driven factory-wheel-driving apparatus.

BACK TO THE PRESENT ~

So what's in North Bloomfield now? Truth be told, there's not much left from the hamlet's old glory days. On the southeast corner of the intersection of Quaker Meeting House and Rt. 65 is Sunny Acres Farm. For over 35 years, Sunny Acres has produced Regional and National level quality Morgan Horse Champions. They specialize in bringing along younger horses, making their early training experiences positive ones from which they can grow.

At 7840 Martin Road you can still appreciate the unique Federal-style architecture of the old North Bloomfield School building, which is now a duplex housing unit. It is the two-story white brick building on the south side of Martin Road between Bragg Street and Ideson Road.

BRAGG STREET ~ In terms of any commercial property remaining in North Bloomfield, other than the horse

farm, there would only be two parcels, both located on Bragg Street, and ironically from the 1950's through the 1970's they were both owned by Smitty's uncles. His Uncle Carlton Crane started Crane's Collision which now operates under the name Crane's & Best Collision.

Next to that, on the corner of Martin Road, is Kaddis Manufacturing. Back in the day, Wesley Crane, or Uncle Tuck as the family referred to him, operated his Enar-co factory in that building. He came up with the name by spelling Crane backwards and tacking on the "o" at the end, so the "co" could stand for "company." That facility is currently occupied by Kaddis Manufacturing, a hardware and fastening manufacturing company.

If you return back to Route 65 you can take in the two locations where the words North Bloomfield still appear on public signage, namely the chapel located at 1924 Rt. 65 and the North Bloomfield Cemetery which can be found across the street.

So as is the case with so many of the historic hamlets that freckle the face of our bygone community maps, North Bloomfield survives primarily as a unique blip in history.
